# Committee news...



## Legislative Committee—Jeff Mulzer, Chair

Between now and Tuesday, Nov. 2, Indiana voters will make decisions on a wide variety of offices and issues - from electing a new U.S. Senator to represent Hoosiers in Washington, D.C., to deciding the balance of power in the Indiana Statehouse and in local courthouses. Voters will also decide if an amendment guaranteeing property tax caps will be added to Indiana's Constitution. Here are seven items for voters to consider as we look toward the General Election: **1. Plan ahead.** Voters may register with their county clerk, county election board or online at [www.IndianaVoters.com](http://www.IndianaVoters.com). To check if you are properly registered, visit the same website or call 1-866-461-8638. Those registering for the first time need a valid Indiana driver's license or state-issued identification number. Voters may find their polling places and driving directions online at [www.IndianaVoters.com](http://www.IndianaVoters.com) by entering a name and date of birth. Voters can also get an advance look at their respective local ballots at the same website, so they will know exactly which candidates and issues they'll be considering. Remember, polls in Indiana are open from 6 a.m. to 6 p.m. on Election Day and sometimes involve waits in line, so please schedule accordingly. **2. Bring photo identification.** When going to the polls, be sure to bring your Indiana or federal government-issued identification card, like a driver's license, U.S. passport or military ID. Voters who don't have photo identification cards can easily obtain one free-of-charge at any Indiana license branch. Branch hours are available online at [www.in.gov/bmv](http://www.in.gov/bmv), are posted at each location, and are generally publicized prior to each election. When seeking a photo ID, voters should bring a birth certificate, pay stub, utility bill or bank statement, and Social Security card or document that includes their Social Security number. **3. Consider voting early.** Those who qualify may vote absentee by mail or by traveling board. All that's needed is completion of a simple form. You may vote by absentee ballot if you have a reasonable expectation that you will be absent from the county during the entire 12-hour period polls are open; have a disability; are at least 65 years old; have official election duties outside your voting precinct; are scheduled to work during the entire 12 hours the polls are open; are confined due to illness or are caring for someone confined due to illness; are prevented from voting because of a religious discipline or holiday that takes place during the time the polls are open; or are a participant in the state's address confidentiality program. Voters may ask about early voting and absentee procedures by calling their county clerk's or election board office. Numbers can be found at [www.IndianaVoters.com](http://www.IndianaVoters.com) or in local phone books. **4. Pay Attention.** Consult area newspapers, radio and television stations for coverage on candidate views concerning topics important to you. This will help in preparing for your Election Day choices. After arriving at your polling site, look for signs posted with directions on how to use the voting machines, a list of voting rights, information on provisional ballots and instructions for filing a complaint if you believe your rights are violated. **5. Know the law.** All polling places must have facilities and machines accessible to elderly voters and those with disabilities. A complete overview of election law is available at [www.in.gov/sos/elections](http://www.in.gov/sos/elections). Voters with questions may find contact information for their respective county election boards as well as information about campaign finance and other election issues on the website. **6. Offer to help.** Contact your county clerk or election board to see if volunteer and paid workers are needed at your neighborhood polling site. Phone numbers are available at [www.IndianaVoters.com](http://www.IndianaVoters.com) **7. Vote!**

## Environmental Committee News—by Ed Clements, Chair

IDEM is developing amendments to Rules concerning Source Specific Operating Agreements (SSOAs) for crushed Stone processing plants.

### **IDEM is proposing the following amendments to the crushed stone processing plant SSOA rule:**

- Expand the list of materials that may be crushed at sources to include concrete and RAP.
- Revise the rule to account for updated AP-42 emission factors.
- Provide options so that a SSOA could be issued without requiring New Source Review.
- Specify either the type of crusher that can be used at the source, or provide new options that specify SSOA limitations that are based on the type of crusher at a source.
- Include new or revised work practice standards, recordkeeping and reporting requirements, test methods, and compliance monitoring requirements so that IDEM may submit this rule to USEPA for approval as part of Indiana's State Implementation Plan (SIP).

### **IDEM seeks comments on the proposed rule making, the comment period deadline is October 15, 2010.**

In the wake of BP's Gulf of Mexico incident, the EPA is expected to increase inspections at facilities that are subject to spill prevention, control and countermeasure (SPCC) requirements. Some areas of SPCC plans that are commonly overlooked include:

#### **Administration**

- The SPCC has not been certified by a PE.
- The SPCC did not have a signature of approval by management
- No self-determination criteria was included.
- The SPCC plan lacks written procedures for inspections and for maintaining inspection records for 3 years.
- Personnel are not properly trained in spill prevention procedures.
- Inspections are not conducted as required.

#### **Storage Tanks**

- Compatibility of tanks with the material stored is not discussed.
- Internal heating coils are not addressed.
- Fuel storage tanks are not subjected to scheduled integrity testing.
- One of the oil storage tanks has no secondary containment.

#### **Piping**

- Warning vehicle operators of exposed pipes is not addressed in the SPCC Plan.
- Facility lacks procedures for capping/blank flanging and labeling out-of-service pipes.
- Buried pipes between the storage tanks and the pumps are not coated or cathodically protected against corrosion.
- Above-ground pipe supports are not adequate to prevent sagging.

#### **Security**

- Facility security measures are not mentioned in the SPCC Plan.
- Facility lighting is not addressed in the SPCC Plan.
- Facility lacks procedures to secure master flow and drain valves and to prevent unauthorized access to starter controls on oil pumps.

### **Additionally, some problems that trigger EPA and state enforcement actions are:**

- Oil sheen on storm water runoff.
- Oil stains on ground or pavement.
- Open drainage pipes in secondary containment areas
- Cracks and other damages to secondary containment structures.

The November 10, 2010 deadline for facilities to amend, prepare, and implement SPCC Plans in accordance with revisions to the SPCC rule promulgated since 2002, has been extended by one year to November 10, 2011.

## Safety Committee News—Matt Bunner, Chair

Rumored to have received the Senate Majority Leader's permission to proceed, West Virginia Democratic senators John Rockefeller and Carte Goodwin on Sept. 28 attempted to secure unanimous consent to move the Robert C. Byrd Mine and Workplace Safety and Health Act of 2010 (S. 3671). Taking up a bill on the floor without committee recommendation is one problem; a bill that is hung up on partisan disagreement is destined to not receive unanimous consent. Such a maneuver on the Senate floor is unusual, because the committee of jurisdiction for this bill is not close to having agreed to, or marked up and reported out, a bill. Rockefeller said he was frustrated that there was no agreement on a bipartisan mine safety bill. He ticked off items included in S. 3671 and then highlighted what he considered the chief objections of opponents to it, including: inclusion of OSHA reforms which opponents consider over-reaching; giving MSHA subpoena power; and extending whistleblower protections.

Sen. Mike Enzi (R-Wyo.), senior Republican on the Senate Health, Education, Labor and Pensions committee, objected to the unanimous consent request, saying that he felt negotiations were progressing on a bipartisan basis until talks were cut off last week. He expressed disappointment that Rockefeller would attempt to move a purely partisan bill, commenting that the Republicans had not been asked into talks until two weeks prior to the August recess.

Rockefeller responded that while he did not question Enzi's commitment to miner safety, the MINER Act, which passed when Enzi was chairman of the HELP Committee, did not go far enough. He said that HELP Committee Chairman Tom Harkin (D-Iowa) and Sen. Patty Murray (D-Wash.), chairman of the Subcommittee on Employment and Workplace Safety, had introduced S. 3671 as a benchmark. Rockefeller added that bipartisan talks had not been called off and expressed optimism that they could continue and an agreement could be reached on a bipartisan mine safety bill.

Rockefeller's move came after the stir he created last week by announcing that staff negotiations on mine safety legislation had broken down because Republican staff would not accept any of the Democratic proposals. The announcement resulted in the cancellation of a negotiating session and a postponement of any additional meetings of the staff working group until after the elections.

Subsequently, Enzi took to the Senate floor on Sept. 23 to say that in fact the staff working group was making progress and suggested there were 14 proposals on which the working group had agreed and another seven waiting to see if there was agreement. He said that five or six would have to be decided by the senators themselves. Enzi staff told NSSGA that no agreements reached were on issues about which NSSGA and its ad hoc mine safety group had expressed concern. Enzi called for passage of legislation on a bipartisan basis and said that he felt that agreement could be reached after the elections, suggesting mine safety legislation could be considered in a lame-duck congressional session.

Meanwhile, in a meeting with Senate Majority Leader Harry Reid's (D-Nev.) staff last week, NSSGA and its ad hoc mine safety partners got the message that there were many items on the lame-duck agenda indicating controversial legislation was less likely. Rockefeller's move on the floor seemed designed to provide an assist to Democratic candidates in West Virginia who are facing very tough elections. Nevertheless, NSSGA won't let down its advocacy as long as the possibility exists that this bill could be brought up in a lame-duck congressional session. NSSGA member outreach and education with congressmen and senators on this critical issue are helpful; staff will keep you informed of developments.
